LODGING Details - Ski and Ride Week at Big Sky Montana

Big Sky ski resort has 1.5 times the acreage of Mammoth. Base elevation at 6,800 and peaks elevation of over 11,000 feet relates to a vertical slope of 4,350 feet. Don't worry about the size of the mountain because there are all types of runs (15% beginner, 25% intermediate, 42% advanced and 15% expert). The average winter snowfall is 400 inches and we are expecting to have an awesome time.

Travel is by Jet Blue from Long Beach non-stop without plane changes. A short shuttle from the airport to the resort is included.

Lodging is reserved in 3 bedroom/3 bath condos and 4 bedroom/ 4 bath condos. Rooms have 1 large or 2 smaller beds, depending on your needs. Don't have a roommate? No problem, we'll get someone of your gender to share the room (not the bed). Not traveling with a bunch of buddies, again no problem. We'll fill the rest of the condo rooms with others.

If you want your own private room. Just check the "Single Supplement" box and you'll have a private room for an extra fee. If you don't want to be in a shared an up scaled condo, you can upgrade to the Huntley Lodge for \$299 per person.
