Opportunities to be More Active in the Club

In another month or so this ski season will end – but our Club runs strong year-round! Do you want to help decide where and when we will ski next season, and what kinds of social and recreational events we will offer? Yes? *Then it's time for YOU to step forward!*

Elected Officers*

President – Presides at monthly General Meetings and Board Meetings, assures that all of the Club's legal and financial responsibilities are met, and assists other officers and appointees in carrying out their duties for the benefit of the Club.

VP of Week Trips – Proposes options for one or more ski/board week-long trips each year, makes reservations (travel, lodging, etc.), arranges for payments, promotes the trips, tracks members' reservations and payments, and makes sure that members have a great experience.

VP of Weekend Trips – Proposes options for 4 to 6 ski/board weekend trips to Mammoth; makes lodging reservations, coordinates transportation and some meals, arranges for payments, promotes the trips, tracks members' reservations and payments, and assures a great experience for members.

VP of Competition – Represents the Long Beach Ski Club to the LA Council and Far West Ski Association regarding interclub ski and board races and promotes members' participation in races.

VP of Social Events – Proposes a variety of monthly social events to keep members connected all year; promotes the events, arranges for payments and collects fees if appropriate, assists the hosts of home events, and works with public venues to assure an enjoyable event for everyone.

Secretary – Signs legal documents on behalf of the Club, takes Minutes at Board Meetings, and maintains club records.

Treasurer – Enters all deposits and payments into our QuickBooks accounting system, make deposits, writes checks for club expenditures and to reimburse pre-approved expenses, generates monthly financial statements for the review of the Board, and assures that tax filing is timely.

Board Members at Large – There are also openings for three additional Directors to serve on the Board to help make decisions. This is a great way to get more involved and take on various tasks for the Club.

* *All elected positions require that the person has been a member in good standing for at least one year.*

Appointed Positions – These positions are also vital to the success of our Club! They include:

Membership Chair – Processes membership applications and payments, welcomes new members, and maintains a roster of club members.

Newsletter Editor – Publishes the *"Ski Breeze"* on the first of each month to inform members about upcoming activities and to report on previous trips and social events.

Webmaster – Updates our club website each month, distributes on-line credit card payments to appropriate officers, sends out the monthly Ski Breeze newsletter, and sends other email blasts authorized by the Board to keep members informed.

Social Media Coordinator – Keeps our Facebook and Meetup pages current and engaging.

LA Council Representative – Represents our club at the monthly meeting of the LA Council of Ski Clubs (part of the FWSA), and brings our Board pertinent information.

You are encouraged to speak to any board member (listed on page 6) to ask questions about any position and may either volunteer yourself or nominate another person. Please contact Barbara Nelson at President@lpsc.org to place your name on the ballot that will be sent in early May. The newly elected officers will be announced at the **Annual Meeting and Banquet on May 23rd**. The new President will then appoint members to the other leadership positions.

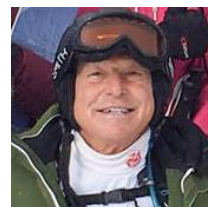
